## **POLICIES OF STARTUP CELL:**

1. Institute will facilitate the startup activities/ technology development by allowing students faculty/ staff to use institute infrastructure and facilities, as per the choice of the potential entrepreneur in the following manners:
  - i. Mentorship support on regular basis.
  - ii. Facilitation in a variety of areas including technology development, ideation, creativity design thinking, fund raising, financial management, cash-flow management, new venture planning, business development, product development, social entrepreneurship, product costing, marketing, brand-development, human resource management as well as law and regulations impacting a business
2. Institute may link the startups to other seed-fund providers/ angel funds venture funds or itself may set up seed-fund once the incubation activities mature.
3. Participation in startup related activities needs to be considered as a legitimate activity of faculty in addition to teaching, R&D projects, industrial consultancy and management duties and must be considered while evaluating the annual performance of the faculty.
4. Every faculty may be encouraged to mentor at least one startup.
5. Product development and commercialization as well as participating and nurturing of startups would now be added to a bucket of faculty-duties and each faculty would choose a mix and match of these activities (in addition to minimum required teaching and guidance) and then respective faculty are evaluated accordingly for their performance and promotion.
6. Start-up: Launching and Sustaining' program: AICTE has launched the 'Start-up: Launching and Sustaining' program to promote entrepreneurship.

Apart from the conduct of various activities at SIBACA, following activities were also undertaken:

- a) **Establishing Industry Connect:** Communication with various companies done for their cooperation and support these activities.
- b) **Entrepreneurial Skill Building Module:** Entrepreneurial skill building module designed by SPPU is available in curriculum. Generic core subject viz. “Start up and New Venture Management” is available for semester 3 of MBA course.
- c) **Case Studies:** Case studies on entrepreneurship are given to students for study. Sample case study with solution by students is available in file.
