Screenshot of speed test port A





IT POLICY



Date: 1st July 2019

Introduction:

IT Policy in Education is much more than the mere collection and distribution of knowledge. It offers intellectual hospitality, opportunities for innovation, creativity; power of thought and imagination. It envisages development of character and inculcation of a firmness of mind and zeal to offer one's best to the world. Education is the means of unfolding moral and spiritual potentialities of men. The initiative to develop an IT Policy of the college is inspired by the tremendous potential of IT for enhancing outreach and improving quality of education. This policy endeavors to provide guidelines to support the stakeholders of SIBACA in optimizing the use of IT resources. Users are currently adhering to all the policies mentioned here.

Importance and role of ICT in an Educational Institution

Meaning of ICT:

Information and Communication Technology Consists of the hardware, software, networks and media for the collection, storage, processing, transmission and presentation of information (voice, data, text, images and videos) as well as related services.

Information and Communication Technologies are defined as all devices, tools, content, resources, forums, and services, digital and those that can be converted into or delivered through digital forms, which can be deployed for realizing the goals of teaching learning, enhancing access to and reach of resources, building of capacities, as well as management of the educational system. These will also include processes for digitization, deployment and management of content, development and deployment of platforms and processes for capacity development, and creation of forums for interaction and exchange.

Scope:

- 1. Respect the rights of others by complying with all college policies regarding sexual, racial and other forms of harassment, and by preserving the privacy of other individuals. For example, it is prohibited to send harassing messages via email or social networking or transmit or reveal personal or private information individuals.
- 2. Use computing facilities, accounts and data only when you have appropriate authorization and use them for approved purposes.
- 3. Respect all pertinent licenses, contractual agreements and copyrights. Use only legal versions of copyrighted software in compliance with vendor license requirements. For example, you should not post another individuals copyrighted material on your web page or install software with a single user license on multiple computers.

- 4. Preserve the integrity of computing systems, electronic data, and communication networks. For example, one should not modify settings on a desktop computer to make it unusable for others or excessively utilize network resources, like music videos, which might overload college network bandwidth.
- 5. Respect and adhere to all appropriate local, state and government laws. For example, it is prohibited to use IT resources of the college to attack computers on another network by launching viruses, worms, or other forms of attack.

Objectives:

SIBACA Information Security Policies are necessary to ensure that important data, Institution plans and other confidential information are protected from theft or unauthorized disclosure.

- 1. The objective of the IT Policy is to devise, catalyze, support and sustain IT and IT enabled activities and processes in order to improve access, quality and efficiency in the education system of the college.
- 2. The IT Policy aims at preparing adult learners to participate creatively in the establishment, sustenance and growth of a knowledge society leading to all round socio- economic development of the nation and global competitiveness.
- 3. Enabling the rapid creation and inexpensive distribution of educational information and knowledge.
- 4. Encouraging professional development, in service training, remote support and mentoring for lifelong learning for teachers, managers and other citizens.
- 5. Facilitating fast and easy access to information and expertise around the world.
- 6. Increasing motivation through the use of multimedia (sound, video, graphics, animation and text.)
- 7. Allowing each student to learn at his/her level and speed thereby giving pupils greater control over their own learning.
- 8. Engaging students in research, data analysis and problem solving, thereby facilitating higher-order thinking processes such as synthesizing, interpreting and hypothesizing.

Privacy:

While the College values and respects the privacy of its staff, faculty, students, and other users, the intrinsic nature of electronic records limits the extent to which the College can guarantee a user's privacy. Despite security protocols, communications over the Internet—and across the local campus network of the college—can be vulnerable to interception and alteration

Personal:

Use Personal use is defined as the non-academic, non-administrative use of IT systems of the college. Such use is solely discretionary; it neither serves an essential employment function nor is it related to academic discourse. Data that result from personal use are "personal data".

Passwords and User IDs

System accounts, passwords, and user IDs plays an important role in protecting the files and privacy of all users. Because users are responsible for all uses made of their accounts, users must take exceptional care to prevent unauthorized use of their accounts. This includes changing passwords regularly and disabling "automatic" log-ins.

Data Storage and Back-ups

The College maintains a centralized repository of data stored in user accounts on the College network. This includes all the data that a user creates and saves on the College's network storage devices. It also includes saved email messages, attachments, files, and folders.

Security

The College implements appropriate "industry-standard" practices concerning the security of the IT resources of the college. These methods are designed to protect against unauthorized access, intrusion, or damage to the availability, access, or integrity of the IT systems of the college.

POLICY STATEMENT

"It shall be the responsibility of the I.T. Department to provide adequate protection and confidentiality of all corporate data and proprietary software systems, whether held centrally, on local storage media, or remotely, to ensure the continued availability of data and programs to all authorized members of staff, and to ensure the integrity of all data and configuration controls."

Other Wireless Devices:

Unapproved wireless devices, such as portable phones and other devices with two-way radios may interfere with the operation of the College wireless network. If the IT department receives a report of interference and determines that a non-approved wireless device is causing interference with the College functioning, it reserves the right to ask the owner of the device to discontinue its use.

ALL THE ABOVE POLICY APPLIES TO:

This policy applies to all students, faculty, and staff of SIBACA, Lonavala and to all other IT users of the "SIBACA, Lonavala". These users are responsible for reading, understanding, and complying with this policy.

Summary of Main Security Policies:

- 1. Confidentiality of all data is to be maintained through discretionary and mandatory access controls, and wherever possible these access controls should meet with security functionality.
- 2. Internet and other external service access are restricted to authorized personnel only.
- 3. Access to data on all laptop computers is to be secured through encryption or other means, to provide confidentiality of data in the event of loss or theft of equipment.
- 4. Only authorized and licensed software may be installed, and installation may only be performed by I.T. Department staff.
- 5. The use of unauthorized software is prohibited. In the event of unauthorized software being discovered it will be removed from the workstation immediately.
- 6. Data may only be transferred for the purposes determined in the Organizations' data-protection policy.
- 7. All diskette drives and removable media from external sources must be virus checked before they are used within the Organization.
- 8. Passwords must consist of a mixture of at least 4 alphanumeric characters, and must be changed every 30 days and must be unique.
- 9. Workstation configurations may only be changed by I.T. Department staff.
- 10. The physical security of computer equipment will conform to recognized loss prevention guidelines.
- 11. To prevent the loss of availability of I.T. resources measures must be taken to backup data, applications and the configurations of all workstations.

VIRUS PROTECTION:

- 1. The I.T. Department will have available up to date virus scanning software for the scanning and removal of suspected viruses.
- 2. Corporate file-servers will be protected with virus scanning software.
- 3. Workstations will be protected by virus scanning software.
- 4. All workstation and server anti-virus software will be regularly updated with the latest anti-virus patches by the I.T. Department.
- 5. No disk that is brought in from outside the Organization is to be used until it has been scanned

- 7. All removable media containing executable software (software with .EXE and .COM extensions) will be write protected wherever possible.
- 8. All demonstrations by vendors will be run on their machines and not the Organizations.
- New commercial software will be scanned before it is installed as it occasionally contains viruses.
- 10. Management strongly endorses the Organizations' anti-virus policies and will make the necessary resources available to implement them.
- 11. Users will be kept informed of current procedures and policies.
- 12. Users will be notified of virus incidents.
- 13. Employees will be accountable for any breaches of the Organizations' anti-virus policies.
- 14. Anti-virus policies and procedures will be reviewed regularly.
- 15. In the event of a possible virus infection the user must inform the I.T. Department immediately. The I.T. Department will then scan the infected machine and any removable media or other workstations to which the virus may have spread and eradicate it.

ACCESS CONTROL:

- 1. Users will only be given sufficient rights to all systems to enable them to perform their job function. User rights will be kept to a minimum at all times.
- 2. Users requiring access to systems must make a written application on the forms provided by the I.T Department.
- 3. Where possible no one person will have full rights to any system. The I.T. Department will control network/server passwords and system passwords will be assigned by the system administrator in the end-user department.
- 4. The system administrator will be responsible for the maintaining the data integrity of the end-user department's data and for determining end-user access rights.
- 5. Usernames and passwords must not be shared by users.
- 6. Usernames and passwords should not be written down.
- 7. Usernames will consist of initials and surname.
- 8. All users will have an alphanumeric password of at least 4 characters.
- 9. Passwords will expire every 30 days and must be unique.
- 10. Intruder detection will be implemented where possible. The user account will be locked after 5 incorrect attempts.

LAN Security Routers & Switches:

LAN equipment, hubs, bridges, repeaters, routers, switches will be kept in secure hub rooms. Hub rooms will be kept locked at all times. Access to hub rooms will be restricted to I.T. Department staff only. Other staff and contractors requiring access to hub rooms will notify the I.T. Department in advance so that the necessary supervision can be arranged.
