### Introduction:

The Director, Technical Education has proposed to the Government to approve the closure / reduction in accessibility of the existing Engineering, Pharmacology, HMTCT, Management Science Courses Degree, Post Graduate Courses in the Institute as per the above mentioned letter.

It was under the consideration of the Government to approve the reduction in existing admissions/discontinuation of courses as shown against the names of institutions in the attached Annexure "A" and Annexure "B" from the academic year 2019-20 as proposed by the Director, Technical Education.

### Government Decision:

As proposed by the Director, Technical Education, as per the approval given by the All India Technical Education Council, New Delhi, from the academic year 2019-2020 the accompanying Annexure A & Annexure B Reduction in accessibility of existing courses/discontinuation of courses as indicated against the names of institutions in Annexure "B" is being approved by the Government subject to the following terms and conditions :-The terms and conditions prescribed earlier while granting approval by the Government for these courses shall remain in force.

1. All documents related to the courses to be discontinued in this institution such as mark sheets, answer sheets, result sheets, student addresses, fee receipts etc. will be required to be handed over by the institution to the concerned university.

2. The head of the institution shall be responsible for all matters relating to the service and other matters of the faculty/staff appointed for the concerned course. If any court case arises in future, the whole organization will be responsible for it.

3. If the recovery of the government from the institution is still outstanding, it will be obligatory on the head of the institution to pay it.

4. In the future, if it is found that the institution has taken a loan from the government or any financial institution regarding the immovable property required to implement the said course in the institution, it will be the sole responsibility of the institution to repay the same.

5. If the admitted students and former students of that institution wish to appear for the examination after the closure of the respective courses in the institution, it shall be obligatory on the institution to make alternative arrangements for the same.

6. The institution shall be bound to pay the salary, compensation and other financial allowance due to the teachers and staff of the institution appointed for the respective course.
